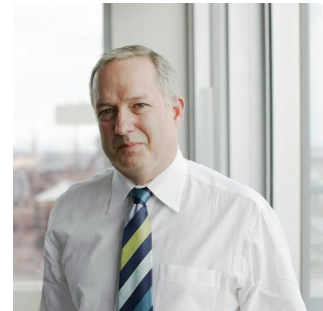
Innovation Guelph appoints four new directors

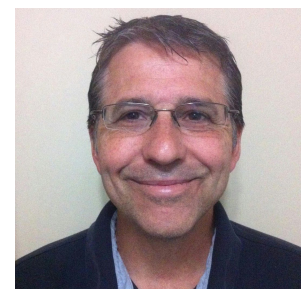

She is a certified fundraising executive, and the 19th Canadian to hold the Association for Healthcare Philanthropy Fellows designation.

An active and dedicated volunteer, she brings more than 20 years experience in the Guelph community working with individuals, organizations, business and community leaders, with particular expertise in fundraising and governance. Ms. Bone is also a Guelph YMCA-YWCA

Woman of Distinction in the Public Service category.
